- 2.2 Candidates shall report to the allotted Institute on or **before the date as per MCC (Reporting to the college)**. The original documents are to be verified by the allotted Institute. (**Note: Candidates to regularly visit the MCC web site**).

4. The candidates provisionally allotted DNB seats shall carry originals with attested copies of documents for verification as under:
  - a. Copy of Senior Secondary/Secondary School certificate showing Date of Birth.
  - b. MBBS/Diploma Certificate
  - c. Result showing NEET PG 2023 rank
  - d. Admit Card NEET PG 2023 Examination
  - e. Copy of Allotment Notice issued by HQ Office
  - f. SC/ST/OBC (Non creamy layer)/PH/EWS Certificate from the 'Appropriate Authority'
  - g. Three (3) Passport size photographs
  - h. Copy of sanction order of 'leave for study purpose' from their 'Appropriate Authority' to ESIC HQ Office.
  - i. Proof of deposit of one-year non-refundable Course Fee of Rs 1,25,000 (excluding payment gateway charges) in ESI-Fund A/C No.2
  - j. Documents/ Certificate as per requirement of NBE
  - k. If at any stage it is found that the candidate has submitted false information/fraudulent certificates or found ineligible, the candidature will stand cancelled.
