### **वर्ष 2024 का कार्यालय आदेश संख्या 270 (ई) OFFICE ORDER NO.270 (E) OF 2024**

Reference is invited towards Regional Office Order No. 202 (E) of 2024 dated 07.06.2024 regarding Annual General Transfer for the 'Transfer Year – 2024' for Group 'C' Cadre officials from whom grievances, if any, were also invited as per transfer policy.

1. Now, Competent Authority, on the recommendations of 'Transfer Grievance Redressal Committee', has considered and disposed of the grievances received from the officials in the above cadre.
2. Accordingly, all the Officials transferred/posted vide Office Order No.202 (E) of 2024 dated 07.06.2024, except the official mentioned at Sl.No. 35, 36, 38, 40, 50, 53, 60 & 72 of said order, shall stand relieved from their present place of posting **w.e.f. 16.07.2024 (A/N)**, if not relieved earlier, with the direction to report at their ordered place of posting in terms of Office Order No. 202 (E) of 2024 dated 07.06.2024.
3. Officials at Sl. No. 35 & 40 of the said order have been allowed for retention up to 31.03.2025 at their present office on the ground that their children are in mid of academic session 2024 – 2025, subject to proper verification of documents by concerned Head of Office/Controlling Officer. After such verification, if found bona fide, they shall, accordingly, be relieved by respective Head of the Office / Controlling Officer on 31.03.2025 (A/N) with the directions to report at their ordered place of posting.
4. Officials in Sl.No.36 & 72 are retained under Spouse Ground. Official Sl.No.38 is retained under Single Mother Ground.
5. The Transfers in respect of Officials in Sl.Nos 50 & 53 are retained under Medical Grounds.
6. The Place of posting in respect of officials in Sl. No.60 & 61 are interchanged based on inter-se tenure seniority. Accordingly the official in Sl. No.60 will join BO-Royapettah on 16.07.2024 and the official of Sl.No.61 shall join the BO-Poonamallee on 17.07.2024.
