## OFFICE ORDER 193 OF 2024

In continuation to Office Order No.365 of 2022 dated 18.11.2022, issued vide file No.37.A.12.23.1.2022.Estt whereby **Shri Akshaykumar R.Thakor, S/o Late Shri R.R.Thakor, MTS, ESIC Model Hospital, Bapunagar**, was appointed as Trainee on temporary basis in ESI Corporation, Regional Office, Gujarat, in relaxation of educational qualification subject to the condition that he should acquire 10th class within a period of 5 years, **the Additional Commissioner and Regional Director has accorded approval for appointment of Shri Akshaykumar R.Thakor to the post of Multi Tasking Staff (MTS)**, on acquiring minimum educational qualification i.e. passing 10th class examination, by the official within stipulated time period.

1. On appointment to the post of Multi Tasking Staff (MTS) , he will draw pay in the Pay Matrix Level-1 of 7<sup>th</sup> CPC plus all applicable allowances as admissible to employees in the ESI Corporation w.e.f. 11.05.2024 (Date of acquiring minimum educational qualification). However, the period of service spent as Trainee will not be counted as service for any purpose.
2. The appointment is provisional and is subject to the Character and Antecedent, Category (SC/ST/OBC), Educational Qualification and any other material information submitted by the candidate, being verified through the proper channels. If on verification, it is found that his claim as SC/ST/OBC category, as the case may be, is false or he has suppressed any material information or has submitted false information, his services will liable to be terminated forthwith without assigning any reason and without prejudice to such further action that may be taken under the Indian Penal Code for production of false certificate.
3. The appointment of Shri Akshaykumar R.Thakor has been made on temporary basis and is subject to such terms and conditions of services as are applicable to similar class of employees and as laid down in ESIC (Staff & Conditions of Services) Regulations, 1959 as amended from time to time.

4. He will be governed by New Pension Scheme introduced w.e.f 01/01/2004 by the Government of India, Ministry of Finance, Department of Expenditure and circulated by Hqrs Office vide Memo No. A/40/11/1/99-Estt-III dated 07.07.2004, for persons joining on or after 01.01.2004.
5. He will maintain properly other family members who were dependent on the deceased Government Servant against whom this appointment on compassionate grounds has been made, and in case, it is proved subsequently (at any time) that the family members are being neglected or are not being maintained properly his appointment may be terminated forthwith.
6. He will be placed on probation for a period of two years from the date of his acquiring minimum educational qualification i.e. 11.05.2024 and his services under the Corporation will be liable to be terminated at any time during the period of probation by giving one-month notice in writing from either side.
7. He is posted as MTS in P.A.Section, at ESI Corporation, Regional Office, Ahmedabad.
