**Subject:** Monthly PMG Review Meetings – Directions for Participation and PMG Portal Up-dation reg.

Sir/Madam,

This is with reference to earlier communications issued by the Headquarters Office, as well as the monthly review meetings being convened under the chairpersonship of the Director General through hybrid mode, with the objective of reviewing the status of projects uploaded on the PMG portal and ensuring their timely and accurate up-dation.

In this context, it is hereby directed that the forthcoming and subsequent review meetings shall be attended exclusively by the **RDs**, duly supported by senior engineers posted in the respective regions. It is to be strictly noted that, under no circumstances, shall officers below the rank of Joint Director or Deputy Director attend these meetings—even in cases where the concerned RD is unable to attend due to pressing or unavoidable reasons. All concerned are instructed to adhere to this directive to ensure uniformity and appropriate representation during the meetings.

In cases where the land acquisition process has been completed and encumbrance-free land has been duly handed over to ESIC, and no further issues or challenges are pending, the concerned Regional Directors (RDs) are requested to update the current status in PMG portal with following remark|:-

(i) "The issue may be marked as resolved since the land has been handed over."  
(Please refer enclosed PMG screenshot)

(ii) And click on the "**Resolved and Send to PMG**" button to initiate further action on marking the issue as resolved on the PMG portal. Similar steps may be taken for other issues also for marking them resolved on the PMG portal.

Further, for all issues- Regional Directors are requested to update the PMG portal with clear and accurate details about the status of land allotment or the progress of issue raised. The update should clearly mention the steps taken by the concerned office and State government in resolution of the issue. This clarity is essential for enabling the PMG team to effectively conclude their follow-up with the concerned State authorities.

Additionally, It is hereby directed that issues pertaining to the ESIC Headquarters or the concerned construction agencies shall not be raised on the PMG Portal. Such matters must be routed internally through the respective Regional Office and Headquarters for appropriate resolution.
