I am directed to state that the Board of Governors at its meeting held on 23.04.2019 considered the Compliance submitted by the college authorities vide letter dated 11.02.2019 along with the previous assessment report May, 2018 on the standard of examination and other teaching facilities for Renewal of recognition of MD(Anaesthesiology) qualification for 2 seats at ESI-PGIMSR,ESI Hospital, K.K Nagar, Chennai granted by The Tamilnadu Dr. MGR Medical University, Chennai and Committee decided as under:-

"The Board of Governors considered the Compliance submitted by the college authorities vide letter dated 11.02.2019 along with the previous assessment report May, 2018 together with the recommendations of the PG Expert Group (BoG) and decided to recommend to the Central Government that the recognition of MD(Anaesthesiology) qualification for 2 seats granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at ESI-PGIMSR,ESI Hospital, K.K Nagar, Chennai be renewed. The Board of Governors further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."
