(2) They have been medically examined and found fit for service in the ESI Corporation.

(3) They will be placed on probation for a period of 02 years from the date of appointment on regular basis and liable to be terminated at any time during the period of probation.

(4) They will be governed by the ESIC (staff and conditions of service) Regulations, 2023, as amended from time to time.

(5) The seniority will be determined in according with the relevant Rules, in due course.

(6) Their appointment is subject to satisfactory verification of their character and antecedents from the concerned Authority and also subject to verification of Educational Qualification, Category/ Caste certificate/ Income and Asset Certificate (SC/ ST/ OBC/EWS/PwBD/ Ex-Serviceman) and further subject to submission/ verification of caste validity certificate, wherever applicable, and any other material information submitted by the candidate. If on verification it is found that his/ her claim as **SC/ST/OBC/EWS/PwBD/Ex-Serviceman** category, as the case may be, is false or he/she has suppressed any material information or has submitted false information, his / her services will be terminated forthwith, without assigning any further reasons and without prejudice to further action may be taken under the provisions of the Indian Penal Code/Bhartiya Nyay Sanhita for having produced false certificate.

(7) They will be governed by the Government of India, New Contributory Pension Scheme effective from 01.01.2004 as implemented in the Employees' State Insurance Corporation.
