TERMS AND CONDITIONS FOR AUCTION/SALE FOR UNSERVICEABLE SCRAP MATERIALS

- 1) The described unserviceable/scrap materials are lying at Regional Office, ESI Corporation, Regional Office, Thrissur – 680 020 under physical possession of the Regional Director, Regional Office, ESI Corporation, Thrissur.
- 2) Sale/Auction of the materials will on “AS IS WHERE IS BASIS” and “WHATEVER THERE IS BASIS” and no guarantee for its worthiness or quality will be given by this office. The sale of Paper waste will be on per Kg basis as per the actual weighed quantity.
- 3) The bidder should deposit a sum of Rs.1000/-(Rupees One Thousand only) as Earnest Money Deposit (EMD). The EMD in the form of Demand Draft (DD) in favour of “ESIC Account No.1” payable at Thrissur, should be kept in an envelope of the sealed cover and shall be dropped on or before 10.11.2025, 10 AM in the tender box placed at the Ground Floor of Regional Office, ESI Corporation, Round Swaraj North, Thrissur along with the bid. The bids received without EMD will summarily be rejected.
- 4) Apart from the quoted amount, GST under Reverse Charge Mechanism is applicable as per rules in force at the time of auction.
- 5) The amount of EMD deposited shall be adjusted from the total amount of payment due from the Successful bidder.
- 6) The EMD of remaining unsuccessful bidders will be returned to them, without interest, after finalization of sale/award of work to the successful bidder.
- 7) No items, once disposed of, from the successful bidder shall be taken back by this office on any condition whatsoever. Any uncleared or unnoticed materials left over by the purchaser within the premises cannot be claimed later.
- 8) The bidder should conduct due diligence on all aspects related to the property to his satisfaction. The bidder shall not be entitled to make any claim against the Authorized Officer in this regard at a later date.
- 9) The ESIC reserves the right to reject any or all offer/bids for the said auction/sale without assigning any reason thereof.
- 10) The items shall be sold/auctioned to the highest bidder.
- 11) The purchase price shall be quoted in figure and words, in the schedule enclosed and in case of any discrepancy in price quoted in figures and words, the price written in words shall prevail.

12) It is the responsibility of the bidder to visit the site and to inspect and satisfy themselves about the unserviceable/scrap materials before participating in the bid. The scrap materials for sale can be inspected by interested bidders on all working day during office hours by contacting the CareTaker, ESI Corporation, Regional Office, Thrissur up to last date/time of bid submission.

13) Conditional tenders will be rejected.

14) Acceptance letter to the highest bidder (H-1 bidder) shall be sent through e-mail/Speed post/Hand delivery.

15) Open auction may also be conducted among the participated bidders or their authorized representatives immediately after opening the sealed quotation on the designated date/time, if required.

16) On receipt of bid acceptance letter, the successful bidder should remit an amount equivalent to 5% of the total bid value immediately to ESIC Account No.1, Thrissur through e-challan.

17) On failure of the successful bidder in paying the amount in the stipulated time, the auction will stand cancelled and the EMD shall be forfeited without any notice, unless time is extended further in writing by ESIC, and scrap materials will be resold.

18) The successful bidder should make necessary arrangements for weighing the items using Weigh bridge / Platform weighing scale/ Machine [as applicable], at his own cost and the same should be done to the entire satisfaction of the Competent Authority. If needed, this office reserves the right to re-weigh the documents by means of any other arrangements.

19) The successful bidder will have to remove the entire weighed items at his own cost, risk and arrangement within 05 days from the date of issue of bid acceptance letter, otherwise the EMD will be confiscated. All items, except newspaper/ Books & Periodicals, should be sent for recycling immediately. The bidder shall be permitted to take the items only after the payment of entire amount to ESIC. There should not be any damage to the properties of this office/ inconvenience in functioning.

20) The successful bidder should produce the proof of remittance of GST under Reverse Charge Mechanism in GST, if applicable.

21) Obtaining all statutory approvals from the Local Bodies/Police/traffic wing required for purchase, Loading/Unloading/clearing or transportation of materials is the sole responsibility of the purchaser only. ESIC cannot be held responsible for any delay or lapses in this regard.
